

### **Acworth Business Association “Female Future Business Leader” Clark Scholarship**

The Acworth Business Association “Female Future Business Leader” Grady Clark Scholarship is awarded to an outstanding high school senior female who has shown leadership skills, been employed during their high school career and demonstrated an entrepreneurial spirit.

One (1) scholarship will be awarded to a graduating high school senior female who currently attends a high school at North Cobb High School, Kennesaw Mountain High School, Allatoona High School or North Cobb Christian School.

The Acworth Business Association “Female Future Business Leader” Clark Scholarship will provide a \$300 award for financial support to offset the cost of educational expenses including, but not limited to, tuition, housing, board or books.

#### **Eligibility Criteria**

Applicant must meet the following criteria to be eligible for consideration by the Acworth Business Association Scholarship Selection Committee.

1. Applicant must be a graduating high school senior attending one of the following high schools: Allatoona, Kennesaw Mountain, North Cobb or North Cobb Christian.
2. Applicant must have demonstrated academic success with a minimum 2.5 GPA.
3. Applicant must have demonstrated leadership in extracurricular activities and community service.
4. Applicants must have been employed at some point during their high school career.
5. Applicant must supply a copy of their high school transcript.
6. Applicant must intent to enroll full-time in an undergraduate program at a fully accredited two- or four-year college/university no later than Fall 2012. Applicants must supply a copy of the acceptance letter for her chosen college/university.  
*NOTE: If acceptance letter is not available before application deadline, submit the application and indicate you are still waiting for the letter.*
7. Applicant must submit a personal essay (300 words or less) outlining the applicant’s future goals and aspirations and what it means to “make your own way in this world.”
8. Applicant must submit one (1) letter of support from individuals who are qualified to address the candidate’s suitability for this award. Letter should be from a teacher, coach, principal, employer or pastor.

Qualified individuals wishing to be considered for the Acworth Business Association "Female Future Business Leader" Clark Scholarship must submit a completed application, including all required materials to:

### Award Notification and Payment

The winning scholarship recipient will be notified in writing no later than April 15, 2012. Scholarship payment will be made in one installment in August 2012 upon receipt of official notification of enrollment/registration for classes. Payment will be made directly to the college or university on behalf of the recipient.

### Recipient's Obligation

Acceptance of the award constitutes permission for Acworth Business Association to use the recipient's name in recognition as a recipient of the scholarship in the organization's publications and announcements. Furthermore, recipient agrees to provide official documentation indicating full-time enrollment at the college or university of her choice before payment will be made. Failure to supply documentation as a registered, degree seeking student will result in revocation of the full amount of the award.

- ◆ Please provide any other comments about the applicant (motivation, initiative in pursuing goals, work responsibilities, community service, etc) that you feel would be helpful for the committee to know.

Your letter of support should be placed in a sealed and signed envelope. The letter should then be returned to the applicant for inclusion in the scholarship application.
